

THE JURORS OF THE GRAND JURY of the State of Ohio, within and for Lucas County, Ohio, on their oaths, in the name and by the authority of the State of Ohio, do find and present that **JEREMY CHESSER**, on or about the 6TH day of AUGUST, 2022, in Lucas County, Ohio, did have sexual contact with another, not the spouse of the offender; cause another, not the spouse of the offender, to have sexual contact with the offender; or cause two or more other persons to have sexual contact, when the other person, or one of the other persons, was less than thirteen (13) years of age, whether or not the offender knew the age of that person, in violation of **§2907.05(A)(4) and (C) OF THE OHIO REVISED CODE, GROSS SEXUAL IMPOSITION, BEING A FELONY OF THE THIRD DEGREE**, contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

SECOND COUNT



FOREPERSON OF THE GRAND JURY

NOTICE TO DEFENDANT

§2929.14(A)(3)(a) For a felony of the third degree that is a violation of section 2903.06, 2903.08, 2907.03, 2907.04 or 2907.05 of the Revised Code or that is a violation of section 2911.02 or 2911.12 of the Revised Code if the offender previously has been convicted of or pleaded guilty in two or more separate proceedings to two or more violations of section 2911.01, 2911.02, 2911.11 or 2911.12 of the Revised Code, the prison term shall be twelve, eighteen, twenty-four, thirty, thirty-six, forty-two, forty-eight, fifty-four or sixty months.

§2929.14(A)(3)(b) For a felony of the third degree that is not an offense for which division (A)(3)(a) of this section applies, the prison term shall be nine, twelve, eighteen, twenty-four, thirty, or thirty-six months.
