Member Alert: Letters of Opposition Needed for Municipal Income Tax Preemption Bill

Good afternoon Mayor,

We have been reporting in our legislative bulletins on HB 519, which preempts municipal income tax by prohibiting a municipal tax administrator from sending any inquiries or send notices to taxpayers with extended tax filing deadlines and eliminates the penalty for taxpayers who have a filing requirement but do not owe any tax. This will prevent municipalities from enforcing compliance on their largest revenue source and from offering taxpayers good customer service. You can find the bill analysis [HERE](#)

We want to alert you that we expect this bill to be up for a third hearing next **Tuesday, March 1 at 3 p.m.** in the **House Ways and Means Committee**. We are asking the members of the Mayor's Association to consider sending a letter opposing HB 519. We have attached a **sample letter** [HERE](#) you can use in drafting your letter.

These numbers correlate to the actual manhole at which interaction between the sanitary and stormwater sewers took place.

DEADLINE EXTENDED FOR UNRESPONSIVE NON-ENTITLEMENT UNITES OF LOCAL GOVERNMENT (NEUs) TO APPLY FOR AMERICAN RESCUE PLAN ACT (ARPA) FUNDS

The following is a communication from the Ohio Office of Budget and Management to unresponsive NEUs:

The American Rescue Plan Act of 2021 (ARPA), passed by the U.S. Congress in March 2021, appropriated \$844 million to the state of Ohio for distribution to local governments with a population less than 50,000. During the previous application period offered by the Office of Budget and Management (OBM), some local governments did not apply for your allocation and was been deemed unresponsive. Funds from unresponsive governments gets redistributed to all other eligible local governments that applied for funds.

The U.S. Treasury released their final rule on January 6, 2022 providing significant flexibility for the use of funds. Previously, funds needed to be used for specific purposes provided in the rule to respond to the COVID-19 pandemic. The final rule added a standard allowance for assumed revenue losses of up to \$10 million. Funds used under the assumed revenue loss category can be used for most general government services, and do not need to tie back to the pandemic or the other eligible use categories. This means that your government entity could use your full allocation toward typical general government expenditures such as road paving, payroll, parks and recreation needs, facility renovations, vehicles, equipment, etc. Local governments have until December 31, 2024 to obligate funds and until December 31, 2026 to fully spend the funding. In addition, the Treasury has communicated minimal reporting requirements when using funds for revenue loss.

In recognition of this new flexibility, OBM is offering one final opportunity for your local government to apply for their allocation. OBM has opened the application portal up through February 11, 2022 to allow for those that were previously unresponsive to apply. The application can be found at <https://grants.ohio.gov/fundingopportunities.aspx> under the funding opportunity titled "American Rescue Plan Act-Coronavirus Local Fiscal Recovery Funds for Ohio Non-Entitlement Units of Local Government."

If OBM does not receive your application by the deadline, your local government will be declared as unresponsive in accordance with the U.S. Treasury requirements and your allocation may be reallocated to other eligible local governments across the state. In addition, unresponsive local governments are not eligible for the second tranche payment. Please consider completing the application; this is a rare opportunity to use one-time funds to address the needs of your community with minimal restrictions.

SEDGWICK WORKER'S COMPENSATION AND SAFETY ARTICLE: DESTINATION EXCELLENCE

The following is a Sedgwick Workers' Comp and Safety article for February 2022:

The Destination Excellence program encourages an employer's focus on safety and return-to-work for injured workers, and fosters efficient management of accounts and cost control efforts. The Destination Excellence program includes Administrative rebates, Safety Council rebates, an Industry Specific Safety bonus, a Drug Free Safety incentive program and a Transitional Work Grant program and bonus.

Savings options

Go Green

A rebate (1% of premium, which includes any assessments, up to a maximum of \$2,000 per policy period) is granted to employers who elect to utilize the BWC's website at www.bwc.ohio.gov to conduct business electronically. BWC will apply the rebate automatically; no application is required. Online transactions consist of reporting payroll; payment of

premium no later than the due date; and any additional transactions that BWC expands to online account management and communications.

Lapse Free

A rebate (1% of premium, which includes any assessments, up to a maximum of \$2,000 per policy period) is granted to employers with an active policy for at least 5 years and no lapses during that time. "One Time Forgiveness" may be utilized to remove a lapse to become eligible. Predecessor policy lapses do not transfer to successor policy but successor policy must be active for at least 5 years to be eligible. Employers reporting zero payroll in current payroll period, state agencies and self-insured employers are not eligible for this discount.

Safety & return-to-work options

Industry Specific Safety Program

A 3% bonus of the employer's premium is given at the close of the program year to encourage an employer's focus on safety in the workplace. Employer must complete an online safety management self assessment and completion of one, two or three loss prevention activities depending on payroll. Loss prevention activities include industry-specific training classes, attendance at BWC's Ohio Safety Congress & Expo and/or onsite field consulting with a BWC safety and health expert.

Drug Free Safety Program

A premium bonus is given for the implementation of a program promoting occupational safety and health for workers which addresses the use and misuse of alcohol and drugs in the workplace. An employer may choose between basic (4% bonus) or advanced (7% bonus) level programs to help their organization prevent on-the-job injuries and illness by integrating drug-free efforts.

Safety Council

This is an incentive program that enables employers to receive a rebate of 2% of their annual workers' compensation premium through program participation and an additional 2% performance bonus based on the reduction of the frequency or severity of claims (reduction of 10% or more compared to the previous year's frequency or severity or maintaining both frequency and severity at zero). Regular attendance at meetings (requirement of 10 meetings or events between July 1 - June 30 annually) provides an organization with the latest in safety, workers' compensation and risk management information, techniques, products and services.

Transitional Work

This is a grant for employers to establish a transitional work plan and a bonus for employers who use the plan in returning injured workers to work. An effective transitional work program helps injured workers return to productivity in the workplace by providing modified job duties and other methods that accommodate medical restrictions. The injured worker receives a full paycheck with the goal of returning to his/her original job

while the employer reduces the costs associated with long-term claims and improves productivity. Grants are 3-to-1 matching grants for companies ranging from \$2,900 to \$6,300 from 11 to 200+ employees. Up to a 10% bonus available for employers who utilize an established and approved program applicable to claims with dates of injury within the policy year.

PEP OFFERS MEMBERS PROPERTY APPRAISAL PROGRAM AT NO ADDITIONAL COST

The Public Entities Pool of Ohio (PEP) continues to offer its members specialized services tailored to meet the needs of its members. In 2018, PEP launched a Property Appraisal program as a benefit to its members at no additional cost.

PEP has partnered with CBIZ Valuation Group, a professional property appraisal firm to perform certified appraisals of member buildings and contents over a five-year period, with the following parameters:

- An on-site appraisal of all buildings valued at \$100,000 or higher.
- For members that do not insure any buildings valued at \$100,000 or higher, the building with the greatest value will be appraised.

Each member will receive a formal report of the appraisal work performed, which will include detailed descriptions and replacement cost insurable values for your records.

If your public entity has been assigned to be appraised this year, you will be contacted by a CBIZ Logistics Coordinator via telephone and/or email in the coming months in order to set up a convenient date and time for you and your staff to host the on-site appraisal visit. The appraisers will be conducting the site visits between the hours of 8:00 am and 5:00 pm, Monday through Friday.

PEP understands that public entity assets need to be properly valued and protected, especially considering current unpredictable building and labor costs. To be sure that CBIZ is able to safely provide this valuable service to the PEP membership, CBIZ has established formal safety protocols for interacting with clients. SUMMARY: The Infrastructure Investment and Jobs Act (Pub. L. 117-58, November 15, 2021, “Bipartisan Infrastructure Law,” or “BIL”) that authorized and appropriated \$1.5 billion to be awarded by the Department of Transportation (“DOT”) for FY 2022 for Local and Regional Project Assistance Program Grants under National Infrastructure Investments, also known as the **Rebuilding American Infrastructure with Sustainability and Equity (RAISE) program**. DOT is required to publish a RAISE Notice of Funding Opportunity (NOFO) no later than 60 days after enactment, which is January 14, 2022. In order to comply with this requirement, the Department is publishing a RAISE NOFO on Grants.Gov for applications, and may include any additional funding appropriated for the RAISE Grants program under the FY 2022 Appropriations Act. If the FY 2022 Appropriations Act significantly alters requirements for the RAISE Grant program, the Department will amend this Notice with guidance on additional requirements. Funds for the FY 2022 RAISE grant program are to be awarded on a competitive basis for surface transportation infrastructure projects that will have a significant local or regional impact.

APPLICATION DEADLINE: Applications must be submitted by 5:00 PM Eastern on April 14, 2022.

ADDRESSES: Applications must be submitted through Grants.gov.

AWARD INFORMATION: The Bipartisan Infrastructure Law of 2021 (“BIL”) authorized and appropriated \$1.5 billion. BIL specifies that the minimum RAISE grant award is \$5 million, except that for projects located in rural areas, the minimum award size is \$1 million. Grants may not be greater than \$25 million. The BIL also directs that not more than 50 percent of the funds provided for RAISE grants (or \$750 million) shall be awarded to rural projects and directs that not more than 50 percent of the funds provided for RAISE grants (or \$750 million) shall be awarded to urban projects. Further, DOT must consider geographical and modal diversity.

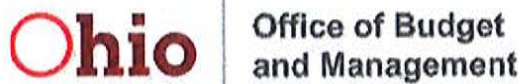

Dear NEU Authorized Representative/Grant Contact,

On January 6, 2022, the U.S. Treasury released the Final Rule for the State and Local Fiscal Recovery Funds. Please see the below press release from Treasury with more details. This Final Rule, effective April 1, 2022, will supersede the previous Interim Final Rule and has several changes. The most notable is the ability to claim a standard allowance of \$10 million in revenue loss for the entire allocation without completing the revenue loss calculation. In Ohio, this will allow every NEU to use their entire allocation as revenue loss. Revenue loss can be used towards general government services such as road paving, facility repairs, equipment, payroll, parks and recreation, etc. which may not be allowable in the other areas of the program. In addition, Treasury has noted significant reduced reporting for the use of funds for revenue loss.

Treasury Issues Final Rule for State and Local Fiscal Recovery Funds Program to Support the Ongoing COVID Response

The final rule enables state and local governments to meet immediate pandemic response needs and promote long-term recovery.

WASHINGTON — Today, the U.S. Department of the Treasury issued the Final Rule for the State and Local Fiscal Recovery Funds (SLFRF) program, enacted as a part of the American Rescue Plan, which delivers \$350 billion to state, local, and Tribal governments to support their response to and recovery from the COVID-19 pandemic.

The SLFRF program ensures governments have the resources needed to respond to the pandemic, including providing health and vaccine services, supporting families and businesses struggling with the pandemic's economic impacts, maintaining vital public services, and building a strong and equitable recovery.

To date, Treasury has distributed more than \$245 billion to state, local, and Tribal governments as a part of the SLFRF program, accounting for over 99% of funds eligible to be disbursed in 2021 – including funds to many communities that had not received federal assistance since the onset of the pandemic. Recipients of funds were encouraged to begin using funds under the interim final rule, which was released in May 2021. Governments have been spending these funds to [address](#) the COVID-19 pandemic and its economic effects, including by expanding access to testing, vaccines, and taking other steps to protect their communities including those that are high-risk and underserved. A [recent analysis](#) by the Center on Budget and Policy Priorities found that state governments have appropriated nearly 70% of their available funds as of November 2021.

“Through the State and Local Fiscal Recovery Funds, the American Rescue Plan has provided state and local governments with the support they need to respond to the ongoing pandemic and plan for an equitable recovery,” said Deputy Secretary of the Treasury Wally Adeyemo. “As the Delta and Omicron variants have illustrated, pandemic response needs will continue to evolve. These funds ensure that governments across the country have the flexibility they need to vaccinate their communities, keep schools open, support small businesses, prevent layoffs, and ensure a long-term recovery.”

The final rule – which takes effect on April 1, 2022 – provides state and local governments with increased flexibility to pursue a wider range of uses, as well as greater simplicity so governments can focus on responding to the crisis in their communities and maximizing the impact of their funds.

The State and Local Fiscal Recovery Funds Program final rule provides additional clarity and flexibility for recipient governments, including:

- First, Treasury has expanded the non-exhaustive list of uses that recipients can use to respond to COVID-19 and its economic impacts – ensuring states and localities can adapt quickly and nimbly to changing public health and economic needs. This includes clarifying that recipients can use funds for certain capital expenditures to respond to public health and economic impacts and making services like childcare, early education, addressing learning loss, and affordable housing development available to all communities impacted by the pandemic.
- Second, Treasury has expanded support for public sector hiring and capacity, which is critical for the economic recovery and in maintaining vital public services for communities.
- Third, Treasury has streamlined options to provide premium pay for essential workers, who bear the greatest health risks because of their service in critical sectors.
- Fourth, Treasury has broadened eligible water, sewer, and broadband infrastructure projects – understanding the unique challenges facing each state and locality in delivering clean water and high-speed broadband to their communities.
- In addition to these expansions, Treasury has greatly simplified the program for small localities – many of whom have received a historic federal investment in their communities through this program – including through the option to elect a standard allowance for revenue loss rather than calculating revenue loss through the full formula.

January 2022 BWC News from Sedgwick

ALL PUBLIC EMPLOYERS MUST SUBMIT 300AP BY FEBRUARY 1

All public employers are required to maintain a log of work-related injuries and illnesses, form 300P, and then submit a summary, the 300AP, to the Public Employment Risk Reduction Program by Feb. 1. If your public entity has more than one establishment or site, you must keep separate records for each physical location. Then, on Feb. 1 of each year, you must post the summary at each of your physical locations until April 30. The 300AP is required under Ohio Administrative Code 4167-6-04(B)(1) as part of the PERRP statistical data collection process.

Required information includes:

- Completion of both the 300P and 300AP
- Verify that you've classified each case only once on both forms.
 - o A case that has one day away and several days restricted would be classified as days away from work, not both. Each case is classified only once, and it is classified as the most serious.
 - o The other recordable case is a case that does not have days away or job transfer or restriction. The case is recordable because it is beyond first aid.
- Verify that the total number of cases equals the total number of injuries and illnesses; otherwise, you will receive an error message and will not be able to submit.

State agencies:

- Submit one master 300AP with the totals for all your departments/establishments.
- Ohio Department of Transportation must submit one master for each district and one master for the central office.
- Ohio Department of Natural Resources must submit one master for each park.
- Ohio Department of Rehabilitation and Corrections must submit one master for each correctional institution.

Counties:

- Submit separate master 300APs for the county entities below.
- County commissioners submit one master 300AP with the total from each of your county departments/establishments, which are under your authority.
- County board of developmental disabilities submit one master 300AP with the total for board employees: and one master 300AP for sheltered workshops.
- County engineer submits one master 300AP.
- County home submits one master 300AP.

Cities, townships, villages, educational institutions:

- Submit only one master 300AP with the totals from all your departments/establishments.

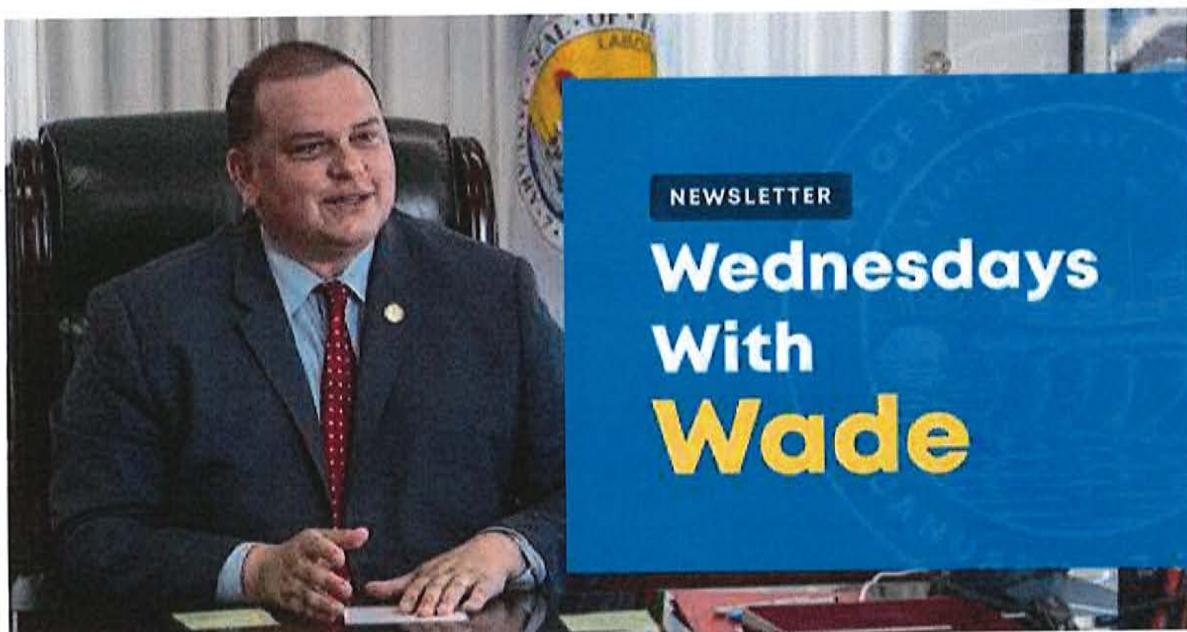

2022 Budget Submitted

According to the City Charter, the mayor is required to submit his or her budget to Toledo City Council by Nov. 15th each year.

On Monday, I met that deadline, and I am proud to say that the **balanced budget proposal I presented** City Council allows us to continue to build on our progress while making sure that taxpayer money is spent wisely and efficiently.

The **2022 proposed budget** revenues total \$890 million and expenditures total \$883 million with a general fund budget of approximately \$279.1 million. We have proposed a capital improvement to general fund transfer of \$18 million and a \$1.1 million reduction in general fund balance. Both of these are necessary to preserve essential city services and ensure we are prepared to handle the impact of the income tax changes made by the State of Ohio regarding remote work.

The 2022 budget, coupled with the Toledo Recovery Plan, will allow us to make unprecedented investments in our city. We will invest in the priorities we know are important to our residents: **public safety, police, roads, youth opportunities, and business and community development.**

For the first time, the budget was created using OpenGov. This tool allows for the creation of the budget, reporting documents, and dashboards that are integrated with SAP, and increases transparency on City of Toledo spending.

The next step is for Toledo City Council to review the budget and work with the administration on its approval. We are anxious to get to work on these critical projects that affect all Toledoans.
