## MICHIGAN CONSUMER PROTECTION ACT (EXCERPT) Act 331 of 1976

#### 445.913 Filing fees for commencing action or filing voluntary assurance.

Sec. 13. When the attorney general or prosecuting attorney commences an action or files a voluntary assurance pursuant to this act, filing fees shall not be required to be paid.

**History:** 1976, Act 331, Eff. Apr. 1, 1977.

#### REVISED JUDICATURE ACT OF 1961 (EXCERPT) Act 236 of 1961

#### 600.1986 Electronic filing system fee; collection; waiver; governmental entity as party; automated payment service fee.

Sec. 1986. (1) Beginning March 1, 2016, if a fee for commencing a civil action is authorized or required by law, in addition to that fee, the clerk shall also collect an electronic filing system fee, subject to section 1993, as follows:

- (a) For civil actions filed in the supreme court, court of appeals, circuit court, probate court, and court of claims, \$25.00.
- (b) Except as provided in subdivisions (c) and (d), for civil actions filed in the district court, including actions filed for summary proceedings, \$10.00.
- (c) For civil actions filed in district court if a claim for money damages is joined with a claim for relief other than money damages, \$20.00.
  - (d) For civil actions filed in the small claims division of district court, \$5.00.
- (2) Subject to section 1991, the clerk shall collect the electronic filing system fee listed under subsection (1) from the party at the time the civil action is commenced, whether or not the document commencing the civil action was filed electronically.
- (3) If the court waives payment of a fee for commencing a civil action because the court determines that the party is indigent or unable to pay the fee, the court shall also waive payment of the electronic filing system fee.
  - (4) A party that is a governmental entity is not required to pay an electronic filing system fee.
- (5) The clerk may accept automated payment of any fee being paid to the court. If the bank or other electronic commerce business charges the court or court funding unit a merchant transaction fee, the clerk may charge the person paying the fee an additional automated payment service fee as authorized by the state court administrative office. The amount of the automated payment service fee shall not exceed the actual merchant transaction fee to be charged to the court or court funding unit for accepting an automated payment by a bank or other electronic commerce business, or 3% of the automated payment, whichever is less.

## ATTORNEY GENERAL'S *EX PARTE* PETITION FOR CIVIL INVESTIGATIVE SUBPOENAS

There is no other pending or resolved civil action arising out of the same transaction or occurrence as alleged in the petition.

#### INTRODUCTION

According to reports filed with the Michigan Department of Agriculture and Rural Development, Michigan shelters facilitated the adoption of over 84,000 companion animals to new owners in 2023.<sup>1</sup> This figure does not include the

numerous companion-animal adoptions completed without the aid of a shelter.

Needless to say, Michigan consumers are fond of animals and are eager to open their homes to animals in need. Unfortunately, bad actors sometimes take advantage of consumers' compassion and generosity.

The unknown Respondent in this case, who utilizes the alias Abby Stratiskii (Stratiskii), purported to be seeking a new home for her dog, "Toby," because she was allegedly threatened with an eviction notice due to Toby's barking. She posted online seeking someone to adopt Toby, and two Michigan consumers searching for a new pet saw the posting and contacted Stratiskii. Stratiskii surrendered Toby to the consumers and provided his veterinary records for an "adoption fee" of \$250. But Stratiskii's story does not pan out—the records Stratiskii provided to the consumers, which allegedly showed Toby's vaccination history, were falsified. And the Attorney General has identified at least two other similar animal-adoption postings linked to Stratiskii. Because there is a probable cause to believe Stratiskii violated the Michigan Consumer Protection Act (MCPA), MCL 445.901 et seq., the Attorney General seeks authority to open an investigation to identify Stratiskii and prevent her from misleading Michigan consumers in the future.

#### PARTIES, LEGAL AUTHORITY, AND VENUE

- 1. The Michigan Attorney General is authorized to file an *ex parte* petition with the circuit court requesting issuance of an investigative subpoena under section 7 of the MCPA, MCL 445.907, which provides in pertinent part:
  - Upon the ex parte application of the attorney general to the circuit court in the county where the defendant is established or conducts business or, if the defendant is not established in this state, in Ingham county, the circuit court, if it finds probable cause to believe a person has engaged, is engaging, or is about to engage in a method, act, or practice which is unlawful under this act, may, after an ex parte hearing, issue a subpoena compelling a person to appear before the attorney general and answer under oath questions relating to an alleged violation of this act. . . . The subpoena may compel a person to produce the books, records, papers, documents, or things relating to an alleged violation of this act. MCL 445.907(1).
- 2. The Attorney General has probable cause to believe that acts or practices defined as unlawful under the MCPA have occurred and continue to occur, as set forth below.
- 3. The true identity of the Respondent in this matter is unknown. This person uses the alias Abby Stratiskii on Facebook and other websites. The purpose of this investigation is to ascertain Stratiskii's true identity. This Petition has been captioned in the matter anticipated by MCR 2.106(C) and MCR 2.201(D).
- 4. Because the transaction precipitating this petition occurred in Kalamazoo County, this Court is an appropriate venue for the Petition.

#### FACTUAL ALLEGATIONS

5. On June 24, 2024, the Michigan Bureau of Professional Licensing forwarded to the Attorney General a complaint it received from Tara, practice manager

- of Companion Animal Clinic (Companion) in Plainwell, Michigan. (Tara Complaint, **Attachment 1**.)
- 6. The Attorney General's office contacted Tara to gather additional details about her complaint.
- 7. Tara explained that Companion received copies of medical records from another veterinarian's office in Michigan, showing that a dog, "Toby," had received certain vaccines at Companion.
- 8. The other veterinarian's office told Companion staff that it wanted to verify the paperwork, as the paperwork had been provided to the dog's new owner when she adopted the dog through the website, <a href="www.rescueme.org">www.rescueme.org</a> (the website).
- 9. The website appears to operate like classified ads, allowing third parties to post information about pets that need to be re-homed.
- 10. The purported records concerned Tara because despite appearing on Companion's letterhead, they were falsified. The records had not been produced by Companion and appeared different from other Companion records. (Records comparison, **Attachment 2**.) One of the pages listed the name "Dr. Christine Lee, DVM," and Companion does not have a doctor by that name. (Tara email, **Attachment 3**.)
- 11. After speaking with Tara, the Attorney General contacted the other veterinarian's office that had attempted to verify the paperwork, Synergy-Parkway Animal Hospital (Synergy) in Ann Arbor.

- 12. After obtaining permission from Toby's owner, Synergy shared with the Attorney General a copy of Toby's medical records, through which the Attorney General identified Toby's current owners.
- Toby's current owners, Consumer 1 and Consumer 2, reside in Ann Arbor, Michigan.
- 14. Special Agent Martin May contacted Consumer 1 and Consumer 2 and interviewed them to gather more information. (May Report for Case No. 2024-040697-A, Attachment 4.)
- 15. Consumer 1 and Consumer 2 explained that in May 2024, they found Toby, a corgi mix purportedly located in Kalamazoo, listed for rehoming on the website corgi.rescueme.org.
- 16. Toby's purported owner, Stratiskii, had indicated in the posting that she had been served with an eviction notice due to Toby's barking.
- 17. Consumer 1 and Consumer 2 met with Stratiskii at the parking lot of the Kalamazoo Cat Clinic in Kalamazoo on May 29, 2024.
- 18. Stratiskii was a petite, white female with brown hair, who appeared to be in her thirties and drove a Honda Fit.
- 19. Stratiskii told Consumer 1 and Consumer 2 that she was Toby's second owner. She also told them that Toby was due for rabies and kennel cough vaccines but was otherwise "up to date on all vaccinations."

  Stratiskii pointed out medical records in a bag, which also contained leashes and supplies for Toby.

- 20. Neither Consumer 1 nor Consumer 2 inspected the veterinary paperwork in Stratiskii's presence.
- Consumer 1 and Consumer 2 decided to take ownership and custody of Toby.
- 22. Consumer 2 provided Stratiskii a cashier's check for \$250.
- 23. Neither Consumer 1 nor Consumer 2 know if Stratiskii cashed the check.
- 24. Upon returning home, Consumer 1 and Consumer 2 began examining Toby's veterinary records and a rabies vaccination tag attached to Toby's collar.
- 25. The rabies vaccination was stamped with tag # 23 95761 and phone number 1-800-427-7973. The phone number resolved to VIP

  Petcare/PETIQ. When Consumer 1 and Consumer 2 called the number, PetIQ operators told Consumer 1 and Consumer 2 they would only release records to the original owner.
- 26. On June 4, 2024, Consumer 1 and Consumer 2 took Toby to Synergy. They turned over the medical records they had received from Stratiskii—the vaccination records from Companion. A Synergy technician told them she had contacted Companion, and Companion denied having treatment records for Toby.
- 27. After the veterinary visit and Companion treatment denial, Consumer 1 texted Stratiskii. Stratiskii texted back that Toby "was definitely up

- to date on vaccinations." Neither Consumer 1 nor Consumer 2 have attempted further contact with Stratiskii.
- 28. Special Agent May was unable to find a female with the last name Stratiskii in Michigan.
- 29. A Facebook profile for Stratiskii was found with pet-related content. That profile states Stratiskii works at a Target Distribution Center in Galesburg. One of the Stratiskii's Facebook "likes" is Pet Vet Family Pet Care Center in Kalamazoo. Stratiskii has multiple posts in Kalamazoo-area animal rescue pages.
- 30. Special Agent May also called Kalamazoo County Animal Control, which confirmed it had no records in its database matching Stratiskii or her phone number.
- 31. Special Agent May tried several other methods to identify Stratiskii using her name or telephone number but was unsuccessful.
- 32. Special Agent May found two other postings by Stratiskii on the Rescue Me website, including a hedgehog and a Golden Retriever, who is no longer available for adoption.

#### VIOLATIONS OF THE ACT

33. When a business represents that a good has sponsorship, approval, characteristics, ingredients, uses, benefits, or quantities that it does not have, that business has engaged in an unfair, unconscionable, or deceptive business practice under the MCPA. MCL 445.903(1)(c).

- 34. Likewise, a business may not fail to reveal a material fact, the omission of which tends to mislead or deceive a consumer, and which fact could not reasonably be known by the consumer. MCL 445.903(1)(s).
- 35. Similarly, it is unlawful for a business to make a representation of fact or statement of fact material to the transaction such that a person reasonably believes the represented or suggested state of affairs to be other than it actually is. MCL 445.903(1)(bb).
- 36. Tara's complaint and Special Agent May's report demonstrate probable cause that the individual operating under the alias Abby Stratiskii has engaged in business practices that violate MCL 445.903(1)(c), (s), and (bb).

#### CONCLUSION AND RELIEF REQUESTED

The Attorney General has brought this Petition for the purpose of opening an investigation into this matter. Authorization is sought to subpoena Meta Platforms, Inc., the operator of Facebook; World Organization d/b/a Rescue Me; and PETIQ, LLC, to learn the identity of the person using the Stratiskii alias and any other relevant information. Authorization to issue additional subpoenas based on what is learned through this effort is also requested.

Accordingly, the Attorney General respectfully requests authorization to issues subpoenas pursuant to the proposed order submitted as **Attachment 5**.

The Attorney General has presented this Court with an *Ex Parte* Petition for Civil Investigative Subpoenas related to an investigation of Respondent Unknown, Unknown a/k/a Abby Stratiskii. Through the *Ex Parte* Petition, the Attorney General alleges that there is probable cause to believe Respondent has violated the Michigan Consumer Protection Act ("Act"), MCL 445.901 *et seq*.

Having had an opportunity to review these materials, this Court finds that probable cause exists to believe Respondent has violated the Act.

THEREFORE, IT IS ORDERED that the Attorney General, acting through her assistants, is authorized to issue a Subpoena to Meta Platforms, Inc., the operator of Facebook; World Organization d/b/a Rescue Me; PETIQ, LLC; and additional subpoenas seeking testimony and documentation from persons and entities that are identified during the course of this investigation.

IT IS FURTHER ORDERED that the Attorney General shall advise all persons issued subpoenas under this Order of the right to be accompanied by counsel in appearing before the Attorney General, and the right to contest the subpoena through motion to this Court.

IT IS SO ORDERED.
