#### The facts upon which such belief is based are as follows:

Starting in 2016 the Ohio Board of Embalmers and Funeral Directors (OBEFD) received numerous complaints against Shawnte Hardin. The complaints allege that Shawnte Hardin is acting as a funeral director in the State of Ohio and is unlicensed and other suspicious activity. The OBEFD followed up on these complaints and found that Shawnte Hardin is unlicensed as a funeral director or embalmer in Ohio.

On 1/12/2018 Toledo Ohio Police executed a search warrant and found the unembalmed body of James Pettaway Jr in a vacant apartment room in Toledo Ohio. The body was in a body bag that was ripped open and lying on a folding table. Dr. Barnett state the body was a health hazard due to sepsis. The body had been transported earlier from the Lucas County Coroner's Office and Shawnte Hardin was to handle the arrangements for the funeral and directed the transport driver to leave the body in the vacant apartment. Lucas County Coroner employee Dionne Fortress stated Shawnte Hardin presented himself as a funeral director. Toledo PD is conducting an abuse of a Corpse investigation with assistance by the Ohio Attorney General Office.

The OBEFD contacted the Ohio Attorney General's Office (AG) in regards to Shawnte Hardin because they only have authority over licensed funeral directors. On 5/14/2019 the AG accepted the case.

Woodlawn Cemetery in Toledo Ohio reported that Shawnte Hardin had written two bad checks totaling \$3,755.00 for two funerals he held at the cemetery. When told of the bad checks Hardin gave them a credit card to use for payment. This credit card was denied by the bank. The cemetery also stated that Shawnte Hardin did not obtain burial permits for the funerals. Police report filed.

Toledo Memorial handled two cremations brought to them by Shawnte Hardin. They made him pay cash because he wrote them a bad check for the last cremation he brought them.

AG case analyst Michael Spiert interviewed Marlin Gray who is a licensed funeral director in Ohio. Mr. Gray stated on one occasion Shawnte Hardin came to his funeral home in Columbus, Ohio to pick up a body. Shawnte Hardin arrived in a station wagon and placed the body in the back of the car on an upside-down coffee table in between the table legs.

The AG subpoenaed Ohio Tax records for Shawnte Davon Hardin Services, Hardin Funeral Home, Celebration of Life Memorial Chapel of America, American Mortuary Services and Transportation. The Ohio Department of Taxation wrote in response to the subpoena that there were no records of filings for these entities. Agent Spiert conducted an interview with Deborah Morton an employee of Mr. Peace cemetery in Akron, Ohio. She stated in April 2019 Shawnte Hardin contacted her and wanted to make indigent burial arrangements for Garrison Rogers. Mr. Rogers died on March 20, 2019 and Shawnte Hardin did not show up for burial until April 12, 2019. She said Shawnte Hardin showed up in an old rusty van with the body in the back. She and two other employees helped Shawnte Hardin unload the casket. She said there was a pronounced small of decomposition coming from the casket. She states the smell was so bad one of the maintenance workers and the check from Shawnte Hardin came back "unable to find account".

A report was filed with Akron PD.

Ohio Bureau of Criminal Investigation (BCI) agent Charlie Snyder conducted and interview with Gloria Oliver. Ms Oliver stated that she hired Shawnte Hardin to provide funeral services for her son who died on May 6, 2019. Ms. Oliver paid Hardin \$4,700,00 to Shawnte Hardin. The funeral was planned for May 14, 2019. The actual burial did not take place until May 16, 2019. Shawnte Hardin told Ms. Oliver he was sorry for the delays blaming the coroner's office. Ms. Oliver then called the cemetery Cleveland Memorial Gardens where she learned that the cemetery was suing Shawnte Hardin and that he was not a licensed embalmer. At the burial on May 16, 2019 the casket would not fit into the vault Shawnte Hardin had ordered. Ms. Oliver said that Shawnte Hardin never told her he was not a licensed funeral director or embalmer. Ms. Oliver later discovered that Lakewood Funeral Home assisted Shawnte Hardin with her sons burial services. Ms. Oliver also said that Shawnte Hardin had not contacted Lakewood Funeral Home for help until May 16, 2019 the date of burial.

OBEFD stated they charged James Donovan a licensed funeral director for allowing Shawnte Hardin to act as funeral director knowing he was unlicensed. OBEFD inspectors had found Shawnte Hardin inside Donovan Funeral Home setting behind the desk and acting as a funeral director. Mr. Donovan owns and operates Donovan Funeral Home in Tallmadge, Ohio.

OBEFD received a tip that Shawnte Hardin was conducting a funeral service for Pearl Field in Akron Ohio. On 2/6/2020 Case Analyst Michael Spiert went to the area of 815-825 Buchtel Ave in Akron. Shawnte Hardin is a pastor at the church there. Agent Spiert observed a Penske rental van license PKB6579 and Uhaul truck Arizona tag AJ78019 in the lot of Shawnte Hardin's church. Spiert then went to Mr. Peace cemetery where the burial was to happen. Employees confirmed that Shawnte Hardin was bringing a body for burial. They said James Donovan did the embalming and that found it strange since Mr. Donovan had previously been fined by OBEFD for his association with Shawnte Hardin. They also said that Shawnte Hardin owes them \$2,000.00. Agent Spiert later found that the Penske van had been reported to Akron PD as being stolen on 1/3/2020 and recovered on 2/17/2020. Akron PD later charged Henry Howze Jr with this theft a warrant is on file. Agent Spiert checked Shawnte Hardin's Facebook page and saw a picture of Henry Howze Jr and Shawnte Hardin together.

Agent Michael Spiert and OBEFD Inspector Seehase interviewed Marvin Johnson owner of Johnson Mortuary Transport Columbus, Ohio. Mr. Johnson said when he first met Shawnte Hardin he introduced himself as a funeral director and that he owns two funeral homes. Mr. Johnson further stated he did two body transports for Roberta Brady and Shawnte Hardin. After the transports he went to Cook and son Funeral Home on Parsons Ave. Columbus, Ohio to thank them for the business. When he entered the funeral home, he saw Shawnte Hardin in the back room wearing scrubs. He said Shawnte Hardin had blood on his clothing and the embalming machine was running. Shawnte Hardin was only a couple feet away from the embalming machine.

#### The facts upon which such belief is based are as follows:

Agent Michael Spiert interviewed Patricia Lawrence, Shalonda Cross and Dewey Edwards regarding the funeral of Will Dennis Edwards. Ms. Cross said they never received a receipt for the funeral of Mr. Edwards. She said the funeral home seems non-existent and phone numbers are no longer active. Mr. Edwards passed on June 4, 2018 in Toledo Ohio. The family was referred to Shawnte Hardin to handle funeral arrangements. Shawnte Hardin told the family he had a funeral business in Akron and Columbus and was wanting to start one in Toledo. The family said Shawnte Hardin acted as a funeral director and handled all of the planning, transport, viewing, church services and cremation. Ms. Lawrence said she thinks Wilkenson funeral home did the embalming. The service was held on June 7, 2018 at Family Baptist Church in Toledo. Ms. Lawrence said she was at the rear of the church for the funeral when a dirty beat up station wagon arrived and two males in white painters clothes and paint all over them took the body out of the back of the truck. The family began trying to call Shawnte Hardin calling over 25 times asking for receipts, death certificate and other papers. The family paid \$3,450.00 directly to Shawnte Hardin. The family did not receive the cremated remains until August 2018. Will Edwards said Shawnte Hardin took his brothers body to Akron for embalming.

On 2/5/2020 agent Michael Spiert spoke to Barbara Koonce reference Shawnte Hardin. She states her brother Tyrone Herron died on July 3, 2018 and she met with Shawnte Hardin. Shawnte Hardin told Ms. Koonce that he was a licensed funeral director in Ohio and he was starting a funeral home in Toledo. Shawnte Hardin told her he did funerals in Akron, Cleveland and Michigan. Ms. Koonce said she paid Shawnte Hardin \$3,000.00 half in cash and half in credit cards. Shawnte Hardin said he would provide embalming, transportation, loaner casket, preparation, urn, cremation and services. Ms. Koonce said Shawnte Hardin is the only person she talked to about funeral arrangements. Ms. Koonce said they were not happy with services provided and had issues in getting her brothers personal property and his cremated remains.

Agent Michael Spiert and OBEFD Inspector Seehase learned that Shawnte Hardin was doing funerals for the Majid Ibnu Taymiyah Mosque on Mock Rd. Columbus, Ohio. When the investigators arrived at the mosque they drove around the back of the building and observed a white casket setting out in the open. Inspector Seehase opened the casket and found it contained body fluids and the casket was ordered from Donovan Funeral Home. This situation was reported to Columbus PD. The investigators spoke with manager, Ali, of the mosque who stated the casket belongs to Shawnte Hardin. The manager said they conduct funerals at the mosque and Mohammed Hussain is the funeral director and Shawnte Hardin did body transports for them. He further stated they stopped using Shawnte Hardin because he always used different rental vehicles to transport bodies and had no business address. Agent Spiert showed the manager a Department of Health application for the Electronic Death Reporting System (EDRS). The document lists the mosque and Mohammed Hussain and Shawnte Hardin as authorized users of the system. The document is signed by Shawnte Hardin and dated 2/26/2020. The manager looked at the document and said this is not correct information and is a forgery. On April 8, 2020 the mosque sent agent Michael Spiert a letter stating that Shawnte Hardin did body transports for the mosque from the station and they have no relationship with Shawnte Hardin at this time.

#### The facts upon which such belief is based are as follows:

On May 3, 2019 Shawnte Hardin wrote a check in the amount of \$1,800.00 to the Village of Mogadore for cemetery expenses. The bank notified the village the account does not exist. The incident was reported to the police and Shawnte Hardin was charged with Passing Bad Checks. Shawnte Hardin was convicted of this charge and is currently on probation through Portage County Common Pleas Court. Heather Al-Hussaini told Mogadore detectives that she paid over \$2,650.00 to Shawnte Hardin for funeral expenses related to this passing bad check case. She also stated that she was supposed to get a head stone and still has not heard from Shawnte Hardin.

On 2/28/2020 the Franklin County Sheriff responded to an incident at the Abubakar Assidlq Islamic Center Mosque in Columbus, Ohio. Deputies in their report state Shawnte Hardin posed as a funeral director and picked up the body of Kevin Mullins from the Franklin County Coroner's Office took it to Donovan Funeral Horne in Akron Ohio to be embalmed. Shawnte Hardin then brought the body to the mosque in Columbus. Mr. Mullins family went to the mosque believing it was a funeral home. Dr. Kebatti from the mosque said they couldn't hold the body for the family as he was not muslim. Shawnte Hardin then decided to have the body kept at a church on Champion Ave. where services will be held the next day. The family was upset at the body being moved around the state before services. The family said they were shocked when they saw the body was being transported in a minivan by Shawnte Hardin. The family said they paid Shawnte Hardin \$5,213.00 for funeral expenses and this was his business and he was the director. Family member Caring Stewart was interviewed by agent Michael Splert and OBEFD Inspector Seehase. She states she still has not received the death certificate from Shawnte Hardin. She said she made all funeral arrangements with Shawnte Hardin and has never heard of Mohammed Hussain.

On 9/18/2020 BCI Agent Azia Mason made an undercover call posing as "Hayden" to Shawnte Hardin. Shawnte Hardin called agent Mason back and agent Mason asked if he could provide cheap funerals. Agent Mason asked Shawnte Hardin if he was a funeral director and he said "yeah" and he was the owner of a funeral business and he has contact with 7 funeral directors and 3 embalmers. Shawnte Hardin told agent Mason he would take care of everything and said basic costs would be \$2,300.00. Shawnte Hardin said he could meet with her at the Abubakar mosque with a funeral director and make the arrangements.

In 2020 agent Spiert made arrangements with the Franklin County Coroner's Office to have video and documents of any bodies that Shawnte Hardin picked up. As of 11/1/2020 Hardin has picked up over 25 bodies from the Franklin County Coroner. Agent Spiert has identified Shawnte Hardin in the videos provided. The Coroner office also stated they have 4 cases in which Shawnte Hardin entered into the state EDRS that the coroner certified the death. These 4 cases were not coroner's cases the state of the Shawnte Hardin change this incorrect information. EDRS shows these body pickups were made up the state in the stat

#### The facts upon which such belief is based are as follows:

On 4/21/20 OBEFD Inspector found on Shawnte Hardin's Facebook page that he is affiliated with HFD Cares and Hussain Funeral Director giving the address of 1509 Blatt Rd. Gahanna Ohio. On 5/21/2020 agent Michael Spiert conducted surveillance at 1509 Blatt Rd. Gahanna Ohio. At 11:50AM Agent Spiert observed a Penske rental van parked by the office. At app 11:56AM agent Spiert observed Shawnte Hardin arrive in a silver coupe. Shawnte Hardin entered into the office with a male white heavy set who got out of the Penske van. At 2:30PM Shawnte Hardin exited the office building and got in the sliver coupe and went north on I 270.

In 2020 Shawnte Hardin listed on Facebook that he was advertising his association with Hussain Funeral Home. Death certificates filed under the name of Mohammed Hussain funeral director for Abubakar Assidiq Islamic Center funeral home show EDRS entries using the names Mohammed Hussain or Shawnte Hardin as reporting person.

- On October 8, 2020, Ohio Bureau of Criminal Investigation (BCI), Special Agent Arvin Clar (SA Clar)
  conducted an interview with Mohammed A. Hussain (Hussain). The interview was partially recorded. The
  interview occurred at Hussain's home located at 10100 Quince Apple Court, Upper Mariboro, Maryland.
- SA Clar was assisted by Sgt. Andrea Sheehan (Sheehan) and Detective Kevin Cruz (Cruz) of the Prince George's County Police Department.
- Hussain is a medical doctor and said that he knows Shawnte "Shawn" Hardin. Hussain also said that the last
  time he spoke with Hardin was sometime in September. Hussain identified an Ohio Bureau of Motor Vehicles
  photo of Hardin. Hussain then said that he is aware that Hardin performs funeral services for people in Ohio and
  that Hussain allows Hardin to use his (Hussain) name and license number to file the electronic EDRS forms. SA
  Clar proceeded to show Hussain an Excel spreadsheet prepared by Troy Seehase (Seehase), the chief
  investigator for the Ohio Department of Board of Embalmers and Funeral Directors, outlining over 100
  certificate of death forms identified as Electronic Death Registration System (EDRS).
- This report prepared by Seehase showed recorded funerals conducted by Hardin with Hussain's name and license number as the "Funeral Service Licensee." SA Clar also displayed copies of the electronic certificates showing Hussain's name and license number #009896.
- Hussain reviewed the information presented by SA Clar and then said that he was only aware of about ten
   (10) funerals and deaths that he allowed Hardin to use his (Hussain) name and license number.
- Hussain confirmed that he did not authorize a large number of the electronic certificates bearing his name and license number. Hussain then said that he is a religious person and allows his name and license number on numerous persons who have died and are buried through the Islamic Church.

- Hussain also said that he authorizes his name and number as charity to the deceased and for the church, and will not accept payment for his services.
- Hussain also strongly denied that he would allow Hardin to use his name without being advised prior to the
  death.
- Hussain recalled that Hardin would call him and let him know when he (Hardin) was performing a funeral
  for the Islamic Community. Hussain again said that he did not believe he authorized more than ten (10) times to
  use his name and license number.
- SA Clar again showed Hussain the Excel spreadsheet prepared by Seehase showing that Hardin did place his (Hussain) name and license, using Hussain's own personal access name and number, through the Electronic Death Registration System (EDRS).
- Hussain again recalled about ten (10) persons he authorized the use of his name and number. The spreadsheet does indicate that Hussain authorized his name and number for 25 deaths.
- Hussain also said that he never authorized Hardin to use his (Hussain) name and license number to perform non-islamic funerals or use his name and license number on the EDRS forms.
- Hussain also said that he never requested payment from Hardin or the Islamic Church for his services of authorizing the death certificates.
- Hussain also said that he rarely came to Ohio to assist in the performing of the funerals for the Islamic Church and relied on persons from the church to assist him, as well as Hardin.
- Hussain said that he works with the Abubaker Mosque in Columbus, Ohlo, to assist the members who have died through the church.

Based on all of the above the affiant believes and has probable cause to believe that evidence of the commission of the criminal offense of Abuse of a corpse 2927.01(B) of the Ohio revised code, will be found at 3880 Sunbury Road Columbus, Franklin County Ohio, specifically, a blue casket containing the remains of an unknown decedent, tools of the disposal and transport of human remains and paperwork for the transport of human remains. Along with the fruits and instrumentalities of the crimes as yet unknown.
