



02/02/2012 EVIDENCE SUBMISSION/DOUBLE HOMICIDE

Summary

On January 31, 2011, S/A Biederstedt assisted the Lucas County Sheriff's Office in a crime scene examination at 2161 Longacre Lane, Holland, Ohio, resulting in a double homicide of **Lisa Straub and John Clarke**. A subsequent investigation ensued by the Lucas County Sheriff's Office.

Details

On 02/02/2012, SAS Biederstedt, Emily Miller (forensic scientist from BCI&I), and BCI&I lab director, Casey Agosti, attended a pretrial conference at the Lucas County Prosecutor's Office. As a result of the discussion, it was determined that SAS Biederstedt would transport potential evidence from the Lucas County Sheriff's Office back to the BCI&I Lab for technical examination and interpretation.

At approximately 1120 hours, SAS Biederstedt arrived at the Lucas County Sheriff's Office. At approximately 1128 hours, SAS Biederstedt opened a brown paper bag labeled item # 26 which contained six (6) white envelopes which had contained Dinar currency. This was done to insure the contents of the brown paper bag. This was resealed immediately by SAS Biederstedt in the presence of deputies.

Evidence transferred to SAS Biederstedt included, Item #17, Item #22, Item #23, Item #26, Item #152, Item #153, and Item #154. The listed evidence was transported by SAS Biederstedt to the BCI&I Lab on this date and submitted for technical examination and interpretation. See the BCI&I evidence submission sheet for description of items submitted.

02/01/2011 AUTOPSY OF STRAUB & CLARKE/HOMICIDE

Summary

On 01/31/11, S/A Biederstedt assisted the Lucas County Sheriff's Office in a double homicide investigation at 2161 Longacre Lane, Holland, Ohio, Springfield Township. Both bodies were discovered bound and deceased in the kitchen of the residence.

Details

On 02/01/11, at approximately 0830 hours, the autopsies of Lisa Straub and John Clarke were conducted at the Lucas County Coroner's Office by Maneesha Pandey, M.D. Present were S/A Biederstedt and Detective Phil Williams.

S/A Biederstedt marked the black duct tape bindings with a red permanent marker for orientation from each body, prior to removal by Dr. Pandey. S/A Biederstedt collected a swab of a reddish brown stain which appeared to be visually consistent with blood from the lower left pant leg of the gray sweatpants worn by John Clarke. Clothing and other items of investigatory value were collected from the autopsy. A dark blue fuzz fabric was collected from right shoulder area of the shirt worn by Lisa Straub.

It was noted that Clarke's left wrist was placed against his back first then his right wrist before duct taping at the wrists. Lisa Straub had her right wrist against her back, and then the left was placed over it before duct taping.

S/A Biederstedt cleared the autopsy at approximately 1445 hours and transported the evidence to the BCI&I office. At approximately 1524 hours, S/A Biederstedt arrived at BCI&I and secured the evidence in temporary evidence locker #4.

On 02/03/11, S/A Biederstedt submitted the evidence for forensic examination and interpretation to the BCI&I Laboratory. See the evidence submission sheet for a complete list of items collected and submitted.

The victims Lisa Straub and John Clarke have been previously identified on the Crime Scene Investigative Report dated 02/01/11.

01/31/2011 HOMICIDE-SCENE EXAMINATION

Summary

See summary by S/A Biederstedt.

Details

S/A Hammond arrived at 2161 Longacre Lane, Holland, Lucas County on 01/31/2011 at 1200 hours. Special Agents Ed Biederstedt and Jeffery Cook were already working at the scene. Deputies from the Lucas County Coroner's Office were also on scene.

S/A Biederstedt requested that S/A Hammond photograph and examine the upstairs rooms for potential evidence. The upstairs was photographed as it was found. A sketch of the rooms was completed.

Examination began in south most bedroom of the upstairs. Damage was noted on the locking mechanism of the bedroom door. It appeared that the wooden six panel door had been forced open. The room was furnished with a queen sized bed, television-entertainment center, night stands, and a wire dog cage. There is a closet in the north wall of the room with a storage cabinet.

It appears that someone had searched through a purse, dumping the contents onto the made bed. A wallet and driver's license for Lisa Straub was found among the contents. A book bag with note books and folders was located on top of the bed. A coat and a jacket was also located on the bed.

The bed side stand north of the bed had a drawer that was pulled out. Items were located scattered on the floor beneath the stand. A key ring with a GM car key and AAA card in the name of Lisa Straub was located on top of the night stand.

A high back chair was located overturned on the floor at the foot of the bed. A nightstand beneath the window in the room had a drawer opened.

Drawers from the storage unit in the bedroom closet had been pulled out and the contents and drawers dumped onto the floor. Items appeared to have been moved or knocked over on shelves in the unit. One item of interest was a ceramic storage jar with a locking lid. The lock was undone and the lid was partially open. The green jar with snow man decals was examined for latent prints. Latent prints were developed, photographed, lifted and retained as evidence.

In addition to the jar, the bed side stands, drawers, light switches, bedroom door, portions of the walls and other items were examined for latent prints.

A small closet north of the previously listed bedroom was then examined. The door to the closet was partially open and there was a metal tin, lying on the floor. This area was photographed and the metal tin was examined for latent prints.

A bathroom was located north of the game closet. The room was photographed. There were no apparent smells of bleach or signs of a clean up. The room was examined for latent prints. The door, light switch and the area of the sink were checked. Latent prints were developed on the sink counter top and lifted. They were retained as evidence.

A spare bedroom was located north of the bathroom. It appears that this room was being remodeled. The room contained a dresser and an ironing board. The room was examined for latent prints.

A small linen/medicine closet was located in the hallway, north of the spare room. The closet door was examined for latent prints.

The master bedroom was located north of the medicine closet. The room is furnished with a king size bed (was made), television entertainment center, night stands and a dresser with mirror. There is a vanity area with sink on the west side of the room. The master bedroom also has a commode/shower area and a walk in closet attached to the vanity area.

The mattress in this room was pushed off of the box springs, presumably to search beneath the mattress. Drawers in the mirrored dresser, the entertainment center and night stands were opened and their contents removed and thrown onto the floor.

Clothes from the walk in closet near the vanity had been removed and thrown onto the floor in front of the sink. A dresser inside the walk in closet had been overturned. A panel leading into the attic space, behind the dresser had been opened.

The master bedroom was searched and items affected by the suspects were examined for latent prints. Latent prints were developed, lifted and retained as evidence.

Cardboard boxes that contained items of jewelry were located in front of the mirrored dresser. These boxes were collected as evidence for latent print examination at a later time.

White envelopes containing a foreign currency were located on the floor of the walk in closet, beneath the dresser that had been knocked over. The envelopes were turned over to S/A Biederstedt.

At the request of S/A Biederstedt, the windows in the home were checked for signs of damage or forced entry. The windows in the upstairs and downstairs were found intact and locked.

Evidence collected by S/A Hammond was turned over to S/A Biederstedt at the scene. S/A cleared the scene at approximately 1700 hours.

01/31/11 CRIME SCENE EXAMINATION/DOUBLE HOMICIDE

Summary

On Monday, 01/31/2011, at approximately 0646 hours, S/A Biederstedt arrived at 2161 Longacre Lane, Holland, Ohio, to assist the Lucas County Sheriff's Office. The road was blocked off at Wynnbrook Court by police tape and a Lucas County Sheriff Deputy. The residence was secured by Lucas County Deputies and Detective Phil Williams. Detective Williams stated that the residence belong to Jeff and Mary Beth Straub parents of the deceased white female, LISA STRAUB. The other deceased person was a white male named JOHN CLARKE, the boyfriend of Lisa Straub.

The Lucas County Sheriff's Office originally received a call at approximately 0130 hours to check the residence. The residence was secure with no answer at the door. A second call was received and the deputies again found the residence secured and received no answer. Finally a third call was received at approximately 0350 hours by Mrs. Clarke indicating that her husband kicked in the front door to gain entry into the residence and discovered the two deceased victims. Deputies responded, as well as firemen, who performed life saving measures, but to no avail.

Details

The residence is a two-story, brown with brick siding residence (attached garage on the south) on the northeast corner of Wynnbrook Court and Longacre Lane, Holland, Ohio, Springfield Township. The front door of the residence faced Longacre Lane, while the garage doors faced to the south. The exterior temperature was documented at 27 degrees. S/A Biederstedt photographed the scene as it was found. In the driveway outside were parked a red Cadillac CTS bearing Ohio License plate CUK4167 registered to Jeffrey Straub and a dark colored Hyundai bearing Ohio license plate AQ60KR registered to Mary Beth Straub. Numerous footwear impressions were around the residence in the snow, although deputies had walked around the residence due to the previous welfare checks. A search warrant was obtained for the residence.

The front interior door with leaded glass window had a footprint outline on the door with the deadbolt still extended. The front door had side leaded glass panel. The door frame displayed a splintering indicating an inward direction. Detective Williams stated that Mr. Clarke (father) had kicked in the door to gain entry. The main floor of the residence going from north to south was comprised of a computer room, foyer with stairs leading to the second floor, and dining room. The foyer extended east (with a door leading to stairs to the basement) and opened up into a step-

down living room with the step-up kitchen to the south, then the laundry room, a ½ bath, and then the 2-½ car garage on the south most end. Two vehicle were documented in the garage. The east most vehicle was a white Pontiac Gran Prix bearing Ohio license plate FDA2741 registered to Lisa Straub and the west vehicle was a black GMC Envoy bearing Ohio license plate FA67ME registered to Jeffrey Straub. The upstairs going from a north to south direction were comprised of the master bedroom with bath, a spare unfinished room, bathroom, and south bedroom (which Lisa Straub's driver's license was found in).

The front door (was previously secured); the patio door leading into the sunroom, the exterior sunroom door, and the exterior southeast service door of the garage were locked upon inspection. The one-half garage door was up approximately 2", although secured with the locking bar into the rail frame. The service door from the garage into the house was closed but not locked. All the windows in the main floor had their window treatment coverings down, which would not allow visibility from the outside. A cigarette butt lay on the floor in the residence next to the doorframe of the service door coming from the garage into the house. The doorstop with small piece of splintered wood was noted on the interior side of the garage service door. The door at the deadbolt plate showed a slight outward bow, although no damage was noted to the doorframe itself. The basement only had one window which was on the north wall. The window was frosted and placed in a window well on the exterior side of the residence. No stopped footwear impressions were documented by the window well.

The interior temperature of the residence was documented at 69 degrees. The TV in the living room was on. The following lights were on; the living room lamp on the end table, kitchen ceiling fan above the table, upstairs hallway light, and the basement light above the pool table. The upstairs rooms were in a ransacked condition. The computer room appeared to be undisturbed. The corner curio cabinet in the dining room had both doors in an opened position.

The Lucas County dog warden arrived at approximately 0925 hours and removed a Rottweiler puppy from the residence.

The kitchen was one step up from the living room. A vent/register was removed from the vertical underside of the step up into the kitchen. A green glass bottle containing coins was on the north end of the kitchen floor at the archway from the living room into the kitchen. A white female (A) wearing red with "TGIF" black shirt and black pants with pink inner waist band, laid supine with her head to the east and her legs bowed out in a west direction. The ankles did not show any ligature marks. The shirt was pulled up below her bra exposing her stomach. The female's head (below the west end of the table) was turned on her left side. The carpet under the kitchen table was pushed toward the east with her face resting on a fold of carpet. The female was bound at the wrists behind her back and black duct tape with a torn white plastic bag around her neck. A pair of black pants with pink inner waist band was below her neck between the duct tape and the rug. The female displayed petechia on her face and was purging from her nose. The female displayed mild rigor with lividity on the back side. The female had medical pads attached to her right side. The white male (B) was found supine with the feet pointed in a northeast position and positioned under the west end of the kitchen table. The head was to the west. The white male was wearing a gray hooded sweatshirt, gray t-shirt, with a partial exposed

blue boxers, gray sweatpants, and white socks. The gray hooded sweatshirt was pulled up exposing the stomach, with a black wallet placed on his stomach. An ID in the wallet belonged to **John Clarke** and was void of any money. The white male was bound with black duct tape at the ankles, at the wrists behind his back, and at the neck with a torn open white plastic baggie attached. The right side of the male's face was upward and facing to the north (facing the female victim) and displayed petichia on his face. A blanched angular area was noted on the right side of the victim's face. Rigor was set with lividity on the back side. The male victim's head was away from the female victim's head. Lucas County Pathologist, Dr. Barnett came on scene at approximately 0810 hours and viewed the bodies. Lucas County Coroner's Investigator, Charles Hunt arrived shortly and also examined the bodies prior to departure. S/A Cook arrived at approximately 0819 hours and assisted S/A Biederstedt in the examination and collection of evidence. A light blue "Bic" lighter was on the floor near the female body. A black t-shirt was on top of the planter near the female body. S/A Biederstedt collected tape lifts for hairs/fibers from the shirt of the female body.

A broken silver touch style LG cell Phone (C) model number LG8575 was on the kitchen floor east of the table and approximately 12" away from the east wall.. The battery for the cell phone was along the east wall under a stand. A 3" knife with black handle (D) was on the kitchen counter toward the edge. A "Wolfgang Puck" knife block missing two knives was along the backsplash of the counter. A cell phone back panel (E) was on the floor at the stove on the south wall. A digital scale (F) was on the southwest corner of the island. On the northwest end of the island was a 7" black handle knife (G). A partial footprint (H) with a circular pattern in a south to north direction was approximately 2'8" south of the male victim's head. A folder with the security alarm documents was scattered about the west end of the kitchen table. A clear plastic zip lock style baggie was on the floor below the south edge of the table. The south chair of the table was positioned next to the island. Some of the kitchen cabinet doors were in an open position. S/A Biederstedt collected a tape lift of two suspected marijuana seeds from the floor near the north end of the counter.

A "Finger Pie" porn DVD case with DVD was cover side up and a fingernail clipper was on the floor in the doorway between the dining room and the kitchen.

A broken black LG Verizon cell phone (I) model number LG-WX9200 was on the living room floor by the patio door. A cell phone battery (J) was north of the black cell phone. The numerical face plate (K) of the cell phone was on the hearth of the fireplace on the north wall of the living room. A circular clock was face down on the living room floor at the base of the fireplace. An empty screw was attached to the fireplace above the mantle. A pile of folded clothes were on the floor between the coffee table and the chair in the northwest corner. An hp laptop (S/N CND80446RJ) was on a chair in the northwest corner of the living room. It was plugged into an outlet on the west wall. The laptop was collected as evidence. A planter was knocked off of the bamboo chest in the southeast corner of the living room near the kitchen railing divider.

The kitchen floor was examined for shoeprints and fingerprints. A more complete shoeprint with circular design was located at the south doorway threshold from the garage hallway into the

kitchen. The shoeprint was headed in a north direction. Another type of shoeprint pattern was located on the kitchen floor between the island and the stove and headed northbound on the east side of the island. The pattern displayed a rectangular lug design. The shoeprints were photographed and collected through an electrostatic lift. The shoes in the laundry room did not have the two designs of shoeprints on the kitchen floor. S/A Biederstedt checked the soles of the boots of the deputies (Sobczak, Williams, Curley, Taylor, and Reidy) at the scene, which did not match those on the kitchen floor.

Toledo Funeral Director Services arrived at approximately 1542 hours for transportation of the bodies. They cleared the scene at approximately 1601 hours.

The computer room had an hp Pavilion (S/N MXK5290BSG) computer on the desk along the south wall, which was collected as evidence.

The basement was a finished basement with a billiards room, a family room, and a ping pong table room. Only one window was located to the basement on the north wall. The breaker box was located in an open closet door on the southeast corner of the basement. All the breakers were in the ON position. Both the closet door under the stairs and the one on the north wall of the basement family room were open.

The upstairs master bedroom was in disarray. The mattress was partially pushed in a southwest position. The jewelry box on the dresser was opened revealing a watch. The nightstand drawers were pulled opened and contents strewn about. The master bedroom closet had a dresser toppled over with drawers opened. The attic access panel on the west wall of the closet was exposed, due to the dresser being toppled from its upright position.

The upstairs south bedroom's door displayed signs of forced entry, indicated by damaged to the door latch and frame. The room was in disarray with a chair upside down and contents from a purse strewn on the bed. A driver's license on the end table was for Lisa Straub. A small white piece of torn plastic similar to that around the victim's heads was on the floor on the north side of the bed. This small white piece of plastic was collected by S/A Biederstedt.

S/A Hammond arrived at approximately 1200 hours to assist in the examination and processing of the residence. S/A Cook assisted in the main floor and S/A Hammond was instructed to examine the upstairs.

S/A Biederstedt provided Detective Phil Williams with some evidence at the scene. S/A Hammond and S/A Cook cleared the scene while the inventory was being completed. S/A Biederstedt cleared the scene at approximately 1745 hours and transported the evidence to the BCI&I office.

S/A Biederstedt arrived at the BCI&I office at approximately 1819 hours and secured the evidence in temporary locker #4.

On 02/03/11, S/A Biederstedt submitted the evidence to the BCI&I Laboratory for forensic examined and interpretation. See the evidence submission sheet for a complete list of items collected and submitted.


